
1.0 TERMS AND CONDITIONS OF SALE

CONTROLLING PROVISIONS: These terms and conditions shall control with respect to any purchase order or sale of Victaulic products.

No alteration, modification or waiver of these terms and whether on Customer's purchase or otherwise shall be valid unless the alteration, modification or waiver is specifically accepted in writing by an authorized representative of Victaulic.

Prices, Designs and Terms and Conditions of Sale are subject to change without notice.

TERMS OF PAYMENT: Within 60 days of invoicing. Maximum legal interest rate charged thereafter.

MINIMUM INVOICE CHARGES: KWON 100,000 net for any single order.

SHIPPING TERMS: Standard shipping terms for all Victaulic Korea LLC orders are EX WORK. Victaulic's warehouse facility located at 117 Sangha-dong, Eojeong-ro, Giheung-gu, Yongin-si, Gyeonggi-do, Korea 16986.

Orders are accepted subject to approval of Victaulic Korea LLC, and contingent upon **acts of God, war, civil disturbance, strikes, labor difficulties, delays of carriers, inability to obtain materials, accidents or any other cause beyond our control.**

Victaulic Korea LLC will endeavor to ship by the scheduled delivery date, but reserves the right to ship within a reasonable period thereafter. **Under no circumstances shall Victaulic Korea LLC be liable for damages of any kind, including but not limited to incidental or consequential damages, lost profits, lost sales or liquidated damages for failure to meet shipping dates.**

Orders, when accepted, cannot be cancelled without consent. No material will be taken back without our written consent. **Orders for non-standard (i.e. non-cancelable and/or non-returnable) material may not be cancelled nor will Victaulic accept return of such material for credit. Victaulic reserves the right to change the designation of products from standard to non-standard and vice versa. This may be done at any time without notice, and without incurring obligation. All material is carefully examined, counted and packed by experienced employees. Claims for corrections must be made within 10 days of receipt of goods. We prove our count by weight. Claims for shortages are subjected to that test. Our responsibility ceases when goods are delivered to carrier in good condition and its receipt obtained. Carriers are responsible for goods lost, damaged or delayed in transit. For your own protection, have transportation company's agent verify damages, shortages or delays and note them on freight bill over his signature.

WEIGHTS: All weights are approximate shipping weights and subject to change without notice.

MATERIALS: Materials are cast, ductile iron castings or fabricated steel, except as noted specifically on certain products.
